1. Exhibit Space: Distribution of exhibitor space will be assigned and priority given upon receipt of payment and agreement. All booth space assignments are at the sole discretion of BHF, however BHF will consider all requests of paid exhibitors.
2. Taxes: Exhibitors are responsible for any and all taxes and fees associated with their activities at the Festival.
3. Limitation on Liability: Exhibitor expressly releases BHF from any liability and waives a) any and all demands, claims, and causes of action in law or in equity, related to any defect, deficiency, failure or impairment of utilities or other facilities, including water, heating, electricity, ventilation, refrigeration, or other mechanical systems failure; b) the conduct, negligence or claims of any exhibitor or attendee; and c) any fire, flood, strike, terrorist attack, weather or other, force beyond control of BHF.
4. No Guarantee of Results: BHF does not warrant or guarantee any particular results of the Festival, nor does it guarantee a particular number of attendees or exhibitors.
5. Product/Service Exclusivity: Product/Service exclusivity is not guaranteed through this reservation; this also includes brand exclusivity.
6. Vendors agree to complete setup within allotted time and be setup by the time doors open. Vendors also agree to remain until the end of the event. We take our reputation and brand seriously and we hold ourselves and our vendors to a high standard. If you are not able or willing to remain setup until the end of the event, please bypass being a vendor until you're able to do so.
7.
